Tournament Rules

This is a handicap tournament. All money prizes will be on a handicap basis (100%), with the exception of optional scratch events.

1. **Eligibility** - All entrants must be females sanctioned by the United States Bowling Congress and hold individual membership cards with the Greater Pensacola USBC Association. USBC Rules and Regulations will govern this tournament.
2. **Averages** - All contestants will use their highest 2016-2017 GPUSBCA yearbook average. Bowlers without a GPUSBCA 2016-17 yearbook average may use their highest GPUSBCA average as of January 1, 2018 based on a minimum of 21 games. All others will bowl scratch. Only Greater Pensacola USBC Association averages will be accepted in this tournament. It shall be each Bowler's responsibility to verify the accuracy of their average. Failure to use the proper average or make a correction prior to completion of the first game of a series shall cause disqualification if submitted average is lower than actual average. Prize winnings will be based on submitted average if it is higher. Rule 319A-2, "10 Pin Rule" **IS IN EFFECT.**
3. **Handicap** - Handicap shall be based on 90% of 220, No Maximum handicap. A right-handed bowler with an established right-handed average must bowl right-handed. Similarly a left-handed average bowler must bowl left-handed. A bowler with a two-handed delivery average must bowl two-handed at all times.
4. **Re-Rate** - While Tournament Manager reserves the right to rerate an entrant, such rerating or adjusting of their legal average should be done by the bowler before the date and time he/she starts to bowl. Local Association Championship re-rating must follow the procedure specified under USBC RULE 319e.
5. **Multiple Participation** - Bowlers may participate up to two (2) times in the **Team** event (provided lineup does not include more than two members from another team entry); however the first team event counts toward ALL events. Multiple doubles participation **will not** be permitted.
6. **Entries** - All entries and fees must be in the hands of the Tournament Manager or postmarked no later than midnight March 6, 2018. No refunds will be made after the entry has been received and scheduled to bowl. The entry fee is \$28.00 per person, per event.
7. **Scheduling** - The team captain will be contacted if the 1st preferred time is not available. **No written confirmations will be mailed.** Three (3) complete games shall be bowled by each team or individual in each event they enter. Singles and Doubles will be scheduled with a maximum of three (3) entries to a pair of lanes. **Doubles will be bowled first and all six (6) games will be bowled on the same pair of lanes.** Additional squads may be added, if necessary.
8. **Check-in** - All bowlers should check-in at tournament table 45 minutes prior to scheduled bowling time. Any player or team arriving late shall begin play with the score counting, beginning with the frame then being bowled. A team refusing to start because a full line-up is not present shall forfeit all games by declining to bowl.
9. **Replacements** - Replacements will be authorized after submitting a substitution request by the team captain or appointee. All substitution requests should be made to the Tournament Manager at least one (1) hour before the bowler's squad time.
10. **Official Score** - Following the verification of scores from the computer printout, the signed recap sheet will be the official score.
11. **Ties** - First place ties in any event will be bowled within 10 days after the close of the tournament with the date and time set by the Tournament Manager. The association will pay the expense of a 3 game roll-off. When a tie for other than 1st place occurs, the prize money will be combined and divided equally among the tied position winners.
12. **Prizes** - All prize money will be returned 100%. A ratio of 1 place for every 8 entries, team, singles and doubles. All Events 1 for every 20. If a team enters scratch all members of the team must enter scratch. Additionally, if a doubles pair enters scratch both individuals must enter scratch. A prize list and bowling schedule will be posted in the tournament host center 24 hours prior to the beginning of the tournament. All prize monies will be awarded within 30 days after the close of the tournament (provided there are no protests). Team captains are responsible for distributing the prize money to their team members within 7 days after receipt of prize money. Plaques will be awarded to handicap and scratch champions in each event.
13. **Management** - The Tournament Manager shall have the authority to decide matters pertaining to the operation of this tournament.
14. **Tournament Dress Code** - While competing, proper attire is required. **No tank tops, short shorts, swimsuits, or spandex. All shirts must have sleeves. NO OBSCENE ATTIRE.** All issues with regard to proper attire will be decided upon by the tournament management.
